GROOMING RELEASE FORM – TERMS & AUTHORIZATION

Your pet's safety is my number one priority. In the event of an accident, you will be notified. Furry Bells LLC will seek immediate veterinary care for your pet.

Health or Medical Problems

Grooming can expose hidden medical issues or aggravate existing ones. This may occur during or after grooming, including the day following the grooming appointment. The client assumes all responsibility and liability, financial or otherwise, for the behavior and health of their pet. The groomer will be held harmless from damages, loss, or claims arising from any known or unknown pre-existing conditions of the pet. All medical expenses for veterinary care will be the responsibility of the pet's owner upon signing this agreement.

Medical Emergencies

The client authorizes the groomer to act as his/her agent in the event of an emergency requiring veterinary services, boarding, or transportation if necessary, and agrees to pay all associated costs. Any and all damages or claims shall include, but not be limited to, advanced age, extreme nervousness, neurosis, illness, previous injury, coat or skin condition, or other medical conditions.

This release gives Furry Bells LLC full authorization to seek medical treatment from the nearest veterinarian. All costs and expenses will be the responsibility of the pet owner.

GROOMING RELEASE FORM – ADDITIONAL POLICIES

Owner Responsibilities – Current Vaccinations

All pets must be current on their rabies vaccination. Proof of rabies vaccination is required by Furry Bells LLC prior to or at the time of service. It is strongly recommended that pets are also up to date on Bordetella and Distemper vaccinations to ensure the safety and well-being of all animals.

Ticks & Fleas

If fleas are found on your pet at the time of grooming, a flea bath will be administered immediately for the health and safety of the pet and groomer. A \$20 flea treatment fee will be added to your total bill. If you do not wish to pay this additional fee, you may choose to reschedule your appointment once the flea issue has been resolved.

Dangerous or Aggressive Dogs – Refusal of Service

Your pet's safety and the safety of the groomer are top priorities. If at any time your pet becomes overly stressed, aggressive, or dangerous to handle, grooming services may be stopped immediately. Furry Bells LLC reserves the right to refuse, stop, or cancel grooming services at any point before, during, or after the grooming process. In such cases, the client is responsible for payment for services rendered up to that point.

Use of Muzzles

For the safety of both the pet and the groomer, the use of a muzzle may be necessary. Muzzles will be applied gently and only when required. Clients must inform the groomer in advance if their pet has a history of biting people or other dogs.

GROOMING RELEASE FORM – MATTED COATS & POLICIES

Matted Coats

Furry Bells groomer will not cause serious or undue stress to your pet by attempting to de-mat severely matted coats. Mats are very painful and difficult to remove. If a shave-down is required, the groomer will notify you before the process takes place. If your pet must be shaved to remove matting, you acknowledge and accept the procedure and all associated risks. An additional charge will be added to your final bill, as this process is time-consuming and causes extra wear on grooming equipment.

After Effects of Mat Removal

Removing mats can result in itchiness, skin redness, self-inflicted irritations, scratches, abrasions, and in some cases, failure of the hair to grow back properly. Some pets may also experience behavioral changes following the grooming process.

Cancellations / No Call – No Show

Cancellations without proper notice and no call–no show appointments may result in refusal of future grooming services at the discretion of Furry Bells LLC.

GROOMING RELEASE FORM – MISSED APPOINTMENTS & PAYMENTS

Missed Appointments Policy

I understand that life happens and emergencies or unexpected changes may occur. Each customer is allowed one missed or skipped appointment within an eight-month period without penalty. If a second appointment is missed or skipped within the same eight-month period, the pet will be removed from the regular route and placed on the waiting list for future availability. If you need to reschedule instead of skipping, and I am able to move your appointment to another day or route, it will not count toward the two missed or skipped appointments.

Payment Policy

Payment is due at the time of service. Furry Bells LLC accepts cash, checks, and electronic payments. Electronic payments may be made through a card reader, Venmo, or PayPal.

Satisfaction Policy

Your satisfaction is important to Furry Bells LLC. If you have any concerns or problems with your grooming service, please notify me within 24 hours after grooming, and I will make reasonable adjustments if you would like anything corrected.
